Guidelines and Restrictions for Reproductions

All reproductions are handled by SCA staff and are dependent on the physical condition of the item. Reproductions are limited to 10% of a book, article, or folder unless otherwise authorized by a curator. Routine photocopy orders can take up to 24 hours to complete. Special requests (such as oversized, color copies, or scans) require additional time and fees. Rush orders will result in an additional 50% charge.
